Back in the 1890's Crooksville, Ohio was a bustling town of merchants, manufacturers and farmers who cultivated the surrounding lands. The one thing missing was a bank.

Therefore, the townspeople had to travel to neighboring towns to do their banking. Of course, that included Crooksville's businessmen. This inconvenience prompted a group of merchants and businessmen to initiate the establishment of The Crooksville Bank. It opened for business in 1902. The rest is history.

86 years later, The Crooksville Bank expanded into South Zanesville by opening an office on Maysville Pike. In 1992 the Bank's name was changed to The Community Bank to reflect a passion to meet the needs of a growing community.

Today, the original Crooksville Bank building still stands in its same location and continues to serve family generations spanning over one hundred years. Its legacy is the Spirit of Community that drives everything we do throughout the entire Community Bank family.
